Description

Graphically display the (causal) effect of a continuous variable on a time-to-event outcome using multiple different types of plots based on g-computation. Those functions include, among others, survival area plots, survival contour plots, survival quantile plots and 3D surface plots. Due to the use of g-computation, all plot allow confounder-adjustment naturally. Description

What is this package about?

This package provides different plotting routines to visualize the (causal) effect of a continuous variable on a time-to-event outcome using a previously fit model and g-computation. Unlike simpler alternatives, such as plotting survival curves for some categories, these plots always correspond to the results obtained by the time-to-event model and give an accurate depiction of the causal effect, if all assumptions are met.

What features are included in this package?

The package includes 11 different plot functions, most based on the **ggplot2** package. Those 11 plotting routines include *value specific survival curves*, *landmark survival probability plots*, *survival time quantile plots*, *survival probability heatmaps*, and *survival area plots*, among others. A description and comparison of these plots can be found in the article associated with this R-package (Denz & Timmesfeld 2022).

What does a typical workflow using this package look like?

All the user has to do is fit a time-to-event model, such as the cox-model, including the continuous variable of interest (and possibly confounders) and plug it into one of the plot functions included in this package. Many different kind of models are supported. See `curve_cont` for more details.

What type of plot should I use?

There is no general answer to this question, but we would usually suggest using a plot method that is able to visualize the causal survival probability both as a function of time and as a function of the continuous variable. The `plot_surv_area`, `plot_surv_heatmap` and `plot_surv_contour` functions do just that. More discussion about this topic can be found in the vignette and the associated paper.

What is the difference between displaying causal effects and associations?

The plots generated by this package offer different ways to depict the association between a continuous variable and a time-to-event outcome. Under certain causal identifiability assumptions, which are described in detail in our article on this topic (see references), this association can be endowed with a causal interpretation. Under these assumptions, the estimates can be interpreted as the survival probability that would have been observed if all individuals in the target population had received a specific level of the continuous variable. If these assumptions are not met, this interpretation is invalid.

Where can I get more information?

The documentation pages contain a lot of information, relevant examples and literature references. Additional examples can be found in the vignette of this package, which can be accessed using `vignette(topic="introduction", package="contsurvplot")`. We also published a preprint of the article about this package on arXiv (see references), which contains an in-depth discussion about the plots and how to interpret them.

Estimate Counterfactual Survival or Failure Probabilities for Levels of a Continuous Variable

Description

This function can be utilized to estimate counterfactual survival curves or cumulative incidence functions (CIF) for specific values of a continuous covariate.

Arguments

data	A <code>data.frame</code> containing all required variables.
variable	A single character string specifying the continuous variable of interest, for which the survival curves should be estimated. This variable has to be contained in the <code>data.frame</code> that is supplied to the <code>data</code> argument.
model	A model describing the time-to-event process (such as an <code>coxph</code> model). Needs to include <code>variable</code> as an independent variable. It also has to have an associated <code>?predictRisk</code> method. See <code>?predictRisk</code> for more details.
horizon	A numeric vector containing a range of values of <code>variable</code> for which the survival curves should be calculated.
times	A numeric vector containing points in time at which the survival probabilities should be calculated.
group	An optional single character string specifying a factor variable in <code>data</code> . When used, the regression standardization is performed conditional on this factor variable, meaning that one estimate is returned for each level of the factor variable. See details for a better description. Set to <code>NULL</code> (default) to use no grouping variable.
cause	The cause of interest. In standard survival data with only one event type, this should be kept at 1. For data with multiple failure types, this argument should be specified. In addition, the <code>cif</code> argument should be set to <code>TRUE</code> in those cases.
cif	Whether to calculate the cumulative incidence (CIF) instead of the survival probability. If multiple failure types are present, the survival probability cannot be estimated in an unbiased way. In those cases, this argument should always be set to <code>TRUE</code> .
contrast	Defines what kind of estimate should be returned. Can be either "none" (default), "diff" or "ratio". When "none" is used, it simply returns the counterfactual survival probabilities (or CIF if <code>cif=TRUE</code>) without any further calculations. If "diff" or "ratio" is used instead, the difference or ratio to some reference value will be returned. See argument below.
reference	Defines what kind of reference value to use when estimating causal contrasts. Only used if <code>contrast!="none"</code> , ignored otherwise. Can be either "km" (using standard Kaplan-Meier estimates as reference) or "value" (using the g-computation estimates of a specific value of the variable as reference). To specify which value to use when using <code>reference="value"</code> , the <code>ref_value</code> argument should be used. See details for more information.

ref_value	A single number corresponding to the reference value used when estimating causal contrasts using <code>reference="value"</code> . See details.
event_time	A single character string specifying the time until the occurrence of the event of interest or <code>NULL</code> (default). Only used when estimating causal contrasts with <code>reference="km"</code> , ignored otherwise. If specified, this variable has to be contained in the <code>data.frame</code> that is supplied to the <code>data</code> argument.
event_status	A single character string specifying the status of the event of interest or <code>NULL</code> (default). Only used when estimating causal contrasts with <code>reference="km"</code> , ignored otherwise. If specified, this variable has to be contained in the <code>data.frame</code> that is supplied to the <code>data</code> argument.
conf_int	Whether to calculate point-wise confidence intervals or not. If <code>TRUE</code> , <code>n_boot</code> bootstrap samples are drawn, the g-computation step is performed on each bootstrap sample and the confidence intervals are calculated using the percentile method from these results. Can get very slow if the dataset is large or there are many values in <code>horizon</code> or <code>times</code> . Using <code>n_cores</code> can speed up the process a lot.
conf_level	A number specifying the confidence level of the bootstrap confidence intervals. Ignored if <code>conf_int=FALSE</code> .
n_boot	A single integer specifying how many bootstrap repetitions should be performed. Ignored if <code>conf_int=FALSE</code> .
n_cores	The number of processor cores to use when performing the calculations. If <code>n_cores=1</code> (default), single threaded processing is used. If <code>n_cores > 1</code> the <code>foreach</code> package and the <code>doParallel</code> package are used to run the calculations on <code>n_cores</code> in parallel. This might speed up the runtime considerably when it is initially slow.
na.action	How missing values should be handled. Can be one of: <code>na.fail</code> , <code>na.omit</code> , <code>na.pass</code> , <code>na.exclude</code> or a user-defined custom function. Also accepts strings of the function names. See <code>?na.action</code> for more details. By default it uses the <code>na.action</code> which is set in the global options by the respective user.
return_boot	Either <code>TRUE</code> or <code>FALSE</code> (default). If <code>TRUE</code> (and <code>conf_int=TRUE</code>) this function will return the individual bootstrap estimates instead of the usual estimates. This may be useful to perform tests or calculate other type of bootstrap confidence intervals manually.
...	Further arguments passed to <code>predictRisk</code> .

Details

This function is used internally in all plot functions included in this R-package and generally does not need to be called directly by the user. It can however be used to get specific values or as a basis to create custom plots not included in this package. Below we give a small introduction to what this function does. A more detailed description of the underlying methodology can be found in our article on this subject (Denz & Timmesfeld 2022).

Target Estimand (default)

By default (`contrast="none"`) this function tries to estimate the survival probability at `times` that would have been observed if every individual in the sample had received a value of `horizon` in

the variable. Let Z be the continuous variable we are interested in. Let T be the time until the occurrence of the event of interest. Under the potential outcome framework, there is an uncountably infinite amount of potential survival times $T^{(Z=z)}$, one for each possible value of Z . The target estimand is then defined as:

$$S_z(t) = E(I(T^{(Z=z)} > t))$$

If we additionally consider a categorical group variable D , the target estimand is similarly defined as:

$$S_{zd}(t) = E(I(T^{(Z=z, D=d)} > t))$$

where $T^{(Z=z, D=d)}$ is the survival time that would have been observed if the individual had received both $Z = z$ and $D = d$.

Target Estimand (using contrasts)

If contrasts are used (contrast!="none"), target estimands based on $S_z(t)$ or $S_{zd}(t)$ are used instead. When using contrast="diff" and reference="km", the target estimand is simply the difference between the observed survival probability in the entire sample (denoted by $S(t)$, estimated using a Kaplan-Meier estimator) and the counterfactual survival probability:

$$\Delta_{KM}(t, z) = S(t) - S_z(t)$$

If contrast="ratio" is used instead, the subtraction sign is simply replaced by a division. If group was specified, $S(t)$ is replaced by $S_d(t)$ (a stratified Kaplan-Meier estimator) and $S_z(t)$ is replaced by $S_{zd}(t)$. Instead of using a Kaplan-Meier estimator as reference, one may also use a specific $S_z(t)$ as reference using reference="value" and setting ref_value to the Z that should be used. All of these causal contrasts and their implications are described in detail in the appendix of our article on this topic (Denz & Timmesfeld 2022).

Estimation Methodology

G-Computation, also known as the *Corrected Group Prognosis* method, *Direct-Standardization* or *G-Formula*, is used internally to estimate the counterfactual survival probability or CIF for values of a continuous variable. This is done by setting the variable to a specific value for all rows in data first. Afterwards, the model is used to predict the survival probability of each individual at all times, given the value of variable and their other observed covariates (which are included in the model as independent variables). These estimates are then averaged for each time point. This procedure is repeated for every value in horizon. If a group is supplied, these calculations are repeated for every possible value in group, with the estimated individual survival probabilities also being conditional on that value.

To obtain valid estimates of the target estimand using this function, the fundamental causal identifiability assumptions have to be met. Those are described in detail in our article on this topic (Denz & Timmesfeld 2022). If those assumptions are not met, the estimates may only be used to showcase simple associations. They cannot be endowed with a counterfactual interpretation in this case.

Supported Models

This function relies on the `predictRisk` function from the **riskRegression** package to create the covariate and time specific estimates of the probabilities. All models with an associated `predictRisk`

method may be used in this function. This includes a variety of models, such as the Cox proportional hazards regression model and the aalen additive hazards model. If the model that should be used has no `predictRisk` method, the user either needs to write their own `predictRisk` method or contact the maintainers of the **riskRegression** package.

Bootstrap Confidence Intervals

By using `conf_int=TRUE`, bootstrap confidence intervals may be estimated. This will draw `n_boot` samples of size `nrow(data)` with replacement from data in the first step. Afterwards, the `model` is fit to each of those bootstrap samples and the `curve_cont` function is recursively called to obtain the estimates of interests for each sample. Using the percentile approach, the bootstrap confidence intervals are calculated. This requires that the `model` object contains a `call` parameter, because the `update()` function is used internally.

Computational Complexity

If many values are included in `times`, `horizon` or both and/or `data` has a lot of rows, this function may become very slow. Since bootstrapping relies on sampling with replacement from the original data and repeating the entire procedure `n_boot` times, this also dramatically increases the runtime. Parallel processing may be used to speed up the computations. This can be done by simply setting `n_cores` to values higher than 1.

Missing Data

Currently, this function does not support advanced handling of missing data. The `data.frame` supplied to `data` should contain no missing data in the relevant columns. To achieve this, the `na.action` argument can be set to "na.omit", which will remove all rows that do contain missing data.

Competing Events

By supplying a model that directly takes into account competing events and using the `cause` argument, the user may also use the functionality offered in this package to create plots in this setting. Internally, the `predictRisk` method will then be used to estimate the conditional cause-specific cumulative incidence function, which will then be used to carry out the g-computation step explained above. **However** the underlying target estimand of this procedure is dependent on which kind of model was supplied. It is therefore not possible to define it here concisely. Future research is necessary to clarify this point. This feature should only be used with great caution.

Value

Returns a `data.frame` containing the columns `time` (the point in time), `est` (the estimated survival probability or CIF) and `cont` (the specific value of variable used). If `group` was used, it includes the additional group column, specifying the level of the grouping variable. If `conf_int=TRUE` was used, it additionally includes the columns `se` (bootstrap standard error of the estimate), `ci_lower` (lower limit of the bootstrap confidence interval) and `ci_upper` (upper limit of the bootstrap confidence interval).

Description

Using a previously fit time-to-event model, this function plots the survival curve as a function of a continuous variable using a 3D surface representation. This function can produce interactive plots using the **plotly** package, or a static image using the **persp** function of the **graphics** package.

Arguments

time	A single character string specifying the time-to-event variable. Needs to be a valid column name of a numeric variable in data.
status	A single character string specifying the status variable, indicating if a person has experienced an event or not. Needs to be a valid column name of a numeric or logical variable in data.
variable	A single character string specifying the continuous variable of interest, for which the survival curves should be estimated. This variable has to be contained in the data.frame that is supplied to the data argument.
data	A data.frame containing all required variables.
model	A model describing the time-to-event process (such as an coxph model). Needs to include variable as an independent variable. It also has to have an associated predictRisk method. See ?predictRisk for more details.
cif	Whether to plot the cumulative incidence (CIF) instead of the survival probability. If multiple failure types are present, the survival probability cannot be estimated in an unbiased way. This function will always return CIF estimates in that case.
na.action	How missing values should be handled. Can be one of: na.fail, na.omit, na.pass, na.exclude or a user-defined custom function. Also accepts strings of the function names. See ?na.action for more details. By default it uses the na.action which is set in the global options by the respective user.

horizon	A numeric vector containing a range of values of <code>variable</code> for which the survival curves should be calculated or <code>NULL</code> (default). If <code>NULL</code> , the horizon is constructed as a sequence from the lowest to the highest value observed in <code>variable</code> with 40 equally spaced steps.
fixed_t	A numeric vector containing points in time at which the survival probabilities should be calculated or <code>NULL</code> (default). If <code>NULL</code> , the survival probability is estimated at every point in time at which an event occurred.
max_t	A number indicating the latest survival time which is to be plotted.
interactive	Whether to draw the 3D surface as a static plot (<code>interactive=FALSE</code> , the default) or as an interactive plot. When <code>interactive=TRUE</code> is used, this function relies on the <code>plotly</code> package. In this case, the only aesthetic arguments that still work are the <code>xlab</code> , <code>ylab</code> and <code>zlab</code> arguments. Everything else has to be set manually using the functionality of the <code>plotly</code> package directly.
xlab	A character string used as the x-axis label of the plot, representing the survival time.
ylab	A character string used as the y-axis label of the plot, representing the survival probability or CIF.
zlab	A character string used as the z-axis of the plot, representing the continuous covariate of interest.
ticktype	A single character: "simple" draws just an arrow parallel to the axis to indicate direction of increase; "detailed" draws normal ticks as per 2D plots. Passed to the <code>ticktype</code> argument in the <code>persp</code> function. Ignored if <code>interactive=TRUE</code> .
theta	Angles defining the viewing direction. <code>theta</code> gives the azimuthal direction and <code>phi</code> the colatitude. Passed to the <code>theta</code> argument in the <code>persp</code> function. Ignored if <code>interactive=TRUE</code> .
phi	See argument <code>theta</code> . Passed to the <code>phi</code> argument in the <code>persp</code> function. Ignored if <code>interactive=TRUE</code> .
col	The color(s) of the surface facets. Transparent colours are ignored. This is recycled to the $(nx-1)(ny-1)$ facets. Passed to the <code>col</code> argument in the <code>persp</code> function. Ignored if <code>interactive=TRUE</code> .
shade	The shade at a surface facet is computed as $((1+d)/2)^{\text{shade}}$, where d is the dot product of a unit vector normal to the facet and a unit vector in the direction of a light source. Values of shade close to one yield shading similar to a point light source model and values close to zero produce no shading. Values in the range 0.5 to 0.75 provide an approximation to daylight illumination. Passed to the <code>shade</code> argument in the <code>persp</code> function. Ignored if <code>interactive=TRUE</code> .
range_x	Either <code>NULL</code> or a numeric vector of length 2, specifying the range of the x-axis. Set to <code>NULL</code> by default, which is equivalent to not changing the values from their default values. Only used when <code>interactive=TRUE</code> , ignored otherwise.
range_y	Same as <code>range_x</code> , but for the y-axis.
range_z	Same as <code>range_x</code> , but for the z-axis.
...	Further arguments passed to curve_cont .

Details

The survival curve or CIF dependent on a continuous variable can be viewed as a 3D surface. All other plots in this package try to visualize this surface by reducing it to two dimensions using color scales or summary statistics. This function on the other hand directly plots the 3D surface as such.

Although 3D plots are frowned upon by many scientists, it might be a good visualisation choice from time to time. Using the `interactive=TRUE` option makes the plot interactive, which lessens some of the valid criticism of 3D graphics. Similar looking plots for the same purpose but using a likelihood-ratio approach have been proposed in Smith et al. (2019).

Value

Returns a `plotly` object if `interactive=TRUE` is used and a matrix when `interactive=FALSE` is used (still drawing the plot).

Description

Using a previously fit time-to-event model, this function plots a single covariate-specific survival curve or CIF. Using either the **plotly** or the **gganimate** package, an animated plot is created that is either simply showing how the curve evolves over values of the continuous covariate, or includes a slide to let the user interact with it.

Details

When the plot doesn't have to be on paper, it is also possible to use animation to represent how the survival curve or CIF changes when different values of a continuous covariate are used. There are two options included in this function. The first one is creating a plot with a slider that can be interactively manipulated by the user (argument `slider=TRUE`). The second option creates a .gif file in which the continuous variable changes constantly over time (argument `slider=FALSE`).

This type of plot is only useful when visualizing the effect on a computer. It is also important to keep in mind that these plots might look slightly different to users with different hardware and or software.

An additional interactive plot can be created using the [plot_surv_3Dsurface](#) function with `interactive=TRUE`.

Details

This function is very similar to a contour plot (see [plot_surv_contour](#)), but with the probability of interest on the y-axis and the color representing the values of the continuous variable of interest. The main advantage of this type of plot is, that it has the same structure as a usual Kaplan-Meier plot. The only difference is that instead of single curves stratified by some variable, the curves are plotted as an area instead.

This is achieved by estimating value-specific curves over the whole range of the continuous covariate using direct standardization and a previously fitted time-to-event model (see [curve_cont](#)). The area between those curves is then simply filled in (using the `geom_stepribbon` function from the **pammtools** package). By using a big number of individual curves, the appearance of a continuously shaded area is created. This is done by default when using the argument `discrete=FALSE`. By using `discrete=TRUE`, only a small number of value-specific curves are estimated, resulting in only a few discrete bins. When using only a few bins, the output is therefore even closer to a contour plot.

The major downside of this plotting method is that it has problems handling non-monotone effects. Curved relationships between the variable and the survival time result in the areas being plotted on top of each other in a standard survival area plot. By using `monotonic=FALSE`, the user may still use

this function for nonlinear effects. This strategy is not optimal when the relationship is very complex, resulting in lots of facets in the plot. We recommend using either the [plot_surv_contour](#), [plot_surv_heatmap](#) or [plot_surv_matrix](#) functions in this case.

Value

Returns a ggplot2 object.

Note

When saving this graphic to .png or .jpg files while using `discrete=FALSE`, they may sometimes contain some barely visible (but very annoying) lines. Those are the divisions between the areas the plot is made off. This only happens when saving this plot to non-vector graphics, which is why we recommend saving it to .pdf or similar file types only. If other file types are necessary, one can set the `transition_size` argument to higher values (such as 0.5 or 1) to remove this problem as well.

Details

By picking a single value of time, we can effectively reduce the dimensions of the plot by one, resulting in a simple curve plot of the survival probability or CIF at the specific point in time as it changes over values of the continuous covariate. By supplying a vector of times to the `t` argument, multiple such curves can be produced in the same plot.

This can be a very effective plotting strategy if there are specific points in time of interest already (even better if those were pre-defined). It is however a poor strategy if a representation of the effect on the survival over time is desired. An empirical example of this strategy using the 5 year risk is given in Shen et al. (2017).

As all plot functions in this package, this plot relies on the `curve_cont` function to calculate the needed probability estimates.

Details

Contour plots are a great way to reduce three dimensions to a two-dimensional plot and therefore lend themselves easily to plot the effect of continuous variable on the survival probability or CIF over time. Heatmaps (as available in the [plot_surv_heatmap](#)) function are very similar, but are often less clear then contour plots. The major downside of these plots is that they do not have the survival probability (or CIF) on the y-axis, which is of course the standard in standard Kaplan-Meier plots. A very similar plot but with the probability of interest on the y-axis can be created using the [plot_surv_area](#) function.

This type of plot has been described in Jackson & Cox (2021). However, the authors of that article propose a different method to estimate the needed data for the plot.

Internally, this function uses the [geom_contour_filled](#) function of the [ggplot2](#) package to create the plot, after estimating the required probabilities using the [curve_cont](#) function.

Details

Heatmaps are a great tool to visualize a three dimensional surface in a two-dimensional plot. A continuous color scale is used to represent the probability of interest. Although this is fine theoretically, it is often hard to read specific information off these plots. Contour lines can be added to the plot in order to make this easier by using `contour_lines=TRUE` in the function call.

In most cases, however, it is probably better to use a proper contour plot instead, which can be produced using the [plot_surv_contour](#) function. This is mostly a matter of taste, which is why both types of plots are included in this package. Another alternative is the to use the [plot_surv_matrix](#) function, which is basically a discretized version of a survival heatmap.

The main advantage of the heatmap and the contour plots is that they can visualize the effect of a continuous covariate regardless of how it was modeled. Non-linear relationships can be visualized just as well as linear ones. The major downside is, that the structure of the plot is not the same as that of a standard Kaplan-Meier plot. An alternative that is closer to the standard plot can be created using the [plot_surv_area](#) function.

Details

Heatmaps are a great tool to visualize a three dimensional surface in a two-dimensional plot. Continuously changing colors over a single area can, however, be difficult to interpret correctly if the color does not change a lot. This version makes the heatmap easier to understand by discretizing the space into equally spaced rectangles. The survival or failure probability is still estimated at a very fine grid of points in time (controlled using the `fixed_t` and `horizon` arguments), but is then aggregated into average probabilities afterwards. The number inside each rectangle then shows the *average* probability inside the region defined by the rectangle. This makes the plot look a lot like a correlation matrix.

The dimensions of the plot can be controlled using the `n_col` and `n_row` arguments. Using high numbers in these parameters makes the plot look more similar to a standard `plot_surv_heatmap` plot. It is recommended to create the `plot_surv_heatmap` plot first to pick appropriate dimensions for the discretized version here.

Details

Survival Time Quantiles are a single value summarizing the entire survival curve. For example, the most prominently used survival time quantile is the median survival time, which can be interpreted as the time at which half of the people in the sample are expected to have experienced the event of interest. This plot shows one or more of these quantiles as a function of a continuous variable of interest.

To calculate the survival time quantiles, it first calls the `curve_cont` function to get estimates of the value-specific survival curves. Afterwards, it uses step function interpolation to read off the survival time quantile from the estimates.

Although this is a simple way to plot the effect of a continuous covariate on the survival, it can give a misleading visualization of the relationship in some situations. Plots that do not use summary statistics, such as the `plot_surv_contour` and `plot_surv_area` plots, may be preferable.

Details

Similar to the `plot_surv_at_t` and `plot_surv_quantiles` plots, this function produces a plot of a survival curve summary statistic as a function of a continuous variable. The summary statistic in question is the restricted mean survival time (RMST), which is the area under a survival curve up to a specific point in time τ . It can be interpreted as the mean survival time of the population up to τ .

First, a range of value-specific survival curves are estimated. The RMST is then calculated for each one using step function interpolation. This only works for survival curves, not for CIFs. If the area under the CIF should be used instead, the `plot_surv_rmtl` function can be used.

An advantage of this method over the `plot_surv_at_t` and `plot_surv_quantiles` function is, that it does take the whole survival curve into account, kind of. Although it is the area under it, it is only calculated up to τ which makes the output dependent on the choice of τ . This, again, can result in deceiving plots in some cases. Plots visualizing the entire survival curves such as `plot_surv_contour` and `plot_surv_area` might be preferable.

Details

This function is essentially equal to the [plot_surv_rmst](#) function. The only difference is that instead of using the restricted mean survival time (RMST), which is the area under the survival curve up to a specific point in time τ , this function uses the restricted mean time lost (RMTL), which is the area under the (cause-specific) CIF up to a specific point in time τ . It can be interpreted as the mean time it takes an individual to succumb to the event of interest before τ .

The reason this is split into two functions is, that the RMTL can be calculated when mutually exclusive competing events are present, while the RMST cannot. The basic pros and cons of the [plot_surv_rmst](#) function still apply here, however. For more information we suggest consulting the documentation page of the [plot_surv_rmst](#) function.
